- Local Sitting: Travelling allowance of Rs. 500.00 per sitting.
- Outstation Sitting: Actuals by Air, Rail or Car, plus out-of-pocket expenses at actuals for boarding, lodging and local transport subject to maximum of Rs. 5000.00 per day in Metropolitan cities and Rs. 4000.00 per day in other cities. A mediator who makes his own arrangements for boarding, lodging, local transport etc. may be paid out of pocket expenses at the rate of Rs. 2500.00 per day, without production of vouchers.

Travel, Boarding & Lodging for Grade-A Mediators:

- Local Sitting: Travelling allowance of Rs. 750.00 per sitting.
- Outstation Sitting: Actuals by Air, Rail or Car, plus out-of-pocket expenses at actuals for boarding, lodging and local transport subject to maximum of Rs. 7500.00 per day in Metropolitan cities and Rs. 6000.00 per day in other cities. A mediator who makes his own arrangements for boarding, lodging, local transport etc. may be paid out of pocket expenses at the rate of Rs. 4000.00 per day, without production of vouchers.

* For mediators not following the IIAM Mediation Fee Schedule, the mediator fee will be based on the rates charged by the mediator.

- The Mediator and Administrative Fee (fee) will be fixed based on the claim, provided that where, apart from the claim, a counter-claim is also made, the fee will be fixed based on the claim or counter claim, whichever is higher.
- The fee shall be payable in equal shares by the parties, provided that where one party fails to pay his share, the other party may pay that share, provided further that where the other party also does not pay the aforesaid share in respect of the claim or the counter-claim, the mediation proceedings may be suspended or terminated.

- If the amount referred in mediation is in a currency other than Indian Rupees, it shall be converted into Rupees at the current official rate of exchange.
- All amounts shall carry additional 18% GST.
- All payment shall be made by cheque payable to “Indian Institute of Arbitration & Mediation”. Payment may also be made by bank transfer to our bank account.
